Program Requirements | Unknown

The Healthy Choice program is a voluntary premium discount program from the Employee Health Plan (EHP) that rewards you for taking action to manage your health. The program provides resources to help you save on your premium and support your overall well-being. When you participate and meet the program requirements, you'll be eligible to earn a discount off next year's premium.

If you have a spouse on the health plan, they can also participate, and together you can achieve the best discount.

Incentive Program | Unknown

Your Incentive Program is **Unknown**. This means the Employee Health Plan does not have enough information to determine your Incentive Program.

How to Get Started

Your Health Visit Form is required to determine which Track(s) you need to participate in to work toward a premium discount. It is recommended to enroll in the required Track(s) by **March 31**.

- Ask your provider to complete and submit a Health Visit Form. Note: The form is due by **Sept. 30**; however, the completed form determines which Track(s) you need to participate in to work toward a premium discount. The form can be found on your Healthy Choice portal or on the EHP website at clevelandclinic.org/healthychoice.
- To start participating before your Health Visit Form is submitted, call an EHP Wellness Specialist at 216.986.1050, option 3 for more information.
- It's essential to check your portal. Once your Health Visit Form is submitted, your Incentive Program will update in your portal, and there, you can view your program requirements.

Next Steps

See important program deadlines and resources below.

- Join your required Track(s) by **March 31** to work toward full credit.
- Join your required Track(s) by **June 30** to work toward partial credit.
- Submit your Health Visit Form no later than **Sept. 30**.

Note: Identification of your Incentive Program is not complete until a Health Visit Form is submitted to the Employee Health Plan by your primary care provider's office.

- Once your Incentive Program is identified in the Healthy Choice portal, you will need to enroll and participate in the required program(s).
